METHODS OF PARTICIPATION

Customers who decide to take part in the 'Win 30 – Web Edition' competition must make a purchase of at least €1.00 in any shop in the shopping centre between 5 May 2025 and 1 June 2025, from Monday to Sunday, between 9.00 am and 9.00 pm.

Entries can be submitted on any day during the competition period from 9:00 am on 5 May until 23:59 pm on 2 June 2025. Each receipt entitles the customer to one entry, regardless of the amount spent. Once used for an entry, the receipt will be invalidated.

During the competition period, the customer must log on to <https://grandaffi.it> and access the prize competition section (via a link on the homepage or QR codes located throughout the shopping centre). They must complete a form by entering their personal details (first name, surname, email, mobile number, postcode and town/city of residence or country of origin). Participants must also confirm that they have read the privacy notice, accept the general terms and conditions of the competition platform, declare that they are of legal age, and agree to the competition rules.

After submitting their personal information, participants must enter the details from their receipt to take part in the competition: shop name, total amount (including cents), date and time of purchase.

Should the customer attempt to enter the same receipt multiple times, an error message will appear stating **'You have already entered this receipt. Please make a new purchase to try again'**.

A certified software will randomly process winning or losing entries with an instant on-screen response, classifying the entry as an **'INSTANT WIN'**.

At this stage, the customer will have the chance to test their luck through a software-generated system. If the entry is a winning one, the message **'YOU'VE WON A €30 VOUCHER'** will appear on screen, and an email will be sent containing instructions on how to claim the prize. Prizes can be collected from the management office of the Grand'Affi Shopping Centre from Monday to Friday, between 9:00 am–1:00 pm and 2:00 pm–5:30 pm, no later than Friday 13 June 2025.

If the entry is unsuccessful, you will see the message **'SORRY, YOU DID NOT WIN – TRY AGAIN WITH ANOTHER RECEIPT'**.

Each prize will be awarded to the winner upon completion of a 'release declaration' including the following details: full name, place and date of birth, town/city and province of residence, and signature. **The winner must also present the original receipt used for the winning entry.**

The €30 VOUCHERS, divided into 3 vouchers of €10 each, can only be used for purchases at participating stores listed in Annex A of these rules, and must be redeemed by no later than Sunday 29 June 2025.

Please note that if a winner is found to have used fraudulent means or acted in breach of the fair conduct of the competition, they will forfeit their right to the prize. In such cases, the Promoter reserves the right to take any action deemed appropriate, in accordance with current legislation, to prevent and inhibit any attempts to bypass the competition system and its intended mechanics.
